

DECISION

On establishing the Organizing Committee for the International Conference on Marine Litter Prevention and Sustainable Practices towards a Circular Economy – MARLISPACE 2026

Pursuant to Resolution No. 25/NQ-DHNT dated September 24, 2025 of the University Council on the promulgation of the Central Tasks for the Academic Year 2025–2026;

Pursuant to Plan No. 1045/KH-DHNT dated October 6, 2025 of the Rector on the organization of the International Conference on Marine Litter Prevention and Sustainable Practices towards a Circular Economy 2026;

At the proposal of the Head of the Department of International Cooperation and the Management Board of the NET-works Project.

HEREBY DECIDED:

Article 1. To establish the Organizing Committee for the International Conference on Marine Litter Prevention and Sustainable Practices towards a Circular Economy - MARLISPACE 2026, including the members listed in the attached Appendix.

Article 2. The Organizing Committee shall be responsible for developing plans, designing the program, coordinating the activities of subcommittees, and directing all tasks related to the Conference organization. The Chairman of the Organizing Committee shall establish the subcommittees and assign specific duties to each member. Members of the Committee shall receive benefits in accordance with the current regulations of the University. The Committee shall automatically dissolve upon completion of its assigned tasks.

Article 3. This Decision takes effect from the date of signing. Heads of relevant units, individuals concerned, and members listed in Article 1 are responsible for implementing this Decision.
